Investigation Narrative

ON 08/23/17 [REDACTED] MET ME AT THE POLICE DEPARTMENT TO MAKE A COMPLAINT. SHE WAS ORDERED BY THE COURT TO BE EVALUATED BY A COUNSELOR FOR HER CASE. SHE WAS GIVEN A LIST AND FOUND THAT [REDACTED] WAS THE CHEAPEST. SHE MADE AN APPOINTMENT FOR EVALUATION FOR AUGUST 9, 2017 AT 1700. SHE MET WITH DANIEL STAATS COUNSELOR FOR [REDACTED]. SHE SAID THAT STAATS WAS A LITTLE WEIRD DURING THE EVALUATION AND AFTER IT WAS DONE HE SAID SHE WOULD NEED 10 VISITS.

[REDACTED] WENT TO THE FIRST OF HER 10 VISITS ON 08/16/17. DURING THIS SESSION HE TOLD [REDACTED] THAT HE AND HIS WIFE WERE IN AN OPEN RELATIONSHIP. HE QUOTED SCRIPTURES TO HER FROM THE SONG OF SONGS ADDING A SEXUAL OVERTONE TO IT. HE TOLD HER THAT HE AND HIS WIFE WERE IN AN OPEN RELATIONSHIP AND HE IS FINE WITH HER SENDING PHOTOS TO OTHER MEN. HE SAID THAT HE IS OKAY WITH THAT AS LONG AS SHE CHOOSES HIM AT THE END OF THE DAY. BEFORE THE SESSION WAS OVER HE TOLD [REDACTED] THAT IT WAS OK TO SEND HIM PHOTOS OF HER, HE EXPLAINED THAT HE HAD A PRIVATE FACE BOOK ACCOUNT AND SHE COULD SEND THEM THERE. HE DID NOT SPECIFY WHAT TYPES OF PHOTOS HE WANTED.

[REDACTED] SAID THAT SHE HAD RECEIVED A FRIEND REQUEST FROM A PETER DUPREE. SHE ACCEPTED THE REQUEST KNOWING IT WAS STAATS. SHE DID THIS BECAUSE SHE DID NOT THINK ANYONE WOULD BELIEVE THAT STAATS WAS BEHAVING INAPPROPRIATELY WITH CLIENTS. [REDACTED] HAD SOME MESSAGES ON HER PHONE SHE HAD RECEIVED FROM STAATS. I PHOTOGRAPHED THEM AND THEY WILL BE SAVED ON THE CID SERVER.

ON 08/16/17 AT 1753 HE SENT THIS MESSAGE TO [REDACTED] VIA FACE BOOK:

"HEY BEAUTIFUL, THIS IS THE SPECIAL ACCOUNT I TOLD YOU ABOUT. NEVER USE MY REAL NAME ON THIS PAGE." HE INCLUDED AT THE END OF THAT TEXT A WINK FACE EMOJI.

ON 08/21/17 [REDACTED] GOT ANOTHER MESSAGE FROM THE DUPREE ACCOUNT:

"HEY"

[REDACTED] DID NOT REPLY. THE FOLLOWING DAY ANOTHER MESSAGE COMES FROM THE DUPREE ACCOUNT:

"HOW ARE YOU DOING?"

[REDACTED] REPLIES:

"OK"

DUPREE:

"GOOD WHEN DO YOU WANT TO CHAT?"

[REDACTED] DID NOT RESPOND. SHE PULLED UP THE PETER DUPREE ACCOUNT ON HER FACE BOOK. IT HAS A BUILDING AS THE PROFILE PHOTO. THE PAGE STATES HE LIVES IN DALTON AND THAT "SUSAN AND I ARE LOOKING FOR SOME FUN." ON ANOTHER PAGE THERE IS A POST DATED 05/06 THAT SAYS "WHO WANTS TO DO SOME EROTIC MESSAGING?" ANOTHER POST DATED 04/12 SAYS "NO ONE CHATTING TONIGHT" A POST DATED 05/31/2016 STATES "WE ARE IN NW GA. ANY OTHER COUPLES IN OUR AREA? SINGLE MALES OR SINGLE FEMALES?"

████████ SAID THAT OTHER THAN HUGGING HER AT THE END OF HER SESSION THERE WAS NO PHYSICAL CONTACT. I EXPLAINED TO ██████████ THAT I DID NOT KNOW IF THESE ACTS ARE CRIMINAL AT THIS TIME HOWEVER I WOULD CONTINUE TO INVESTIGATE THE MATTER.

AFTER SPEAKING TO ██████████ I CONTACTED GEORGIA DEPARTMENT OF COMMUNITY SUPERVISION OFFICER ADAM PEYTON. I WANTED TO KNOW IF THEY HAD RECEIVED COMPLAINTS ON STAATS IN THE PAST. HE WAS AWARE OF A COLLEAGUE WHO HAD AN EXPERIENCE WITH HIM. ██████████ ██████████ HAD USED STAATS SERVICES BACK IN 2011. ONE NIGHT SHE RECEIVED A MESSAGE FROM STAATS ON FACE BOOK. SHE RECALLED THAT THE MESSAGE READ SOMETHING LIKE A QUESTION. SHE COULD NOT QUOTE THE MESSAGE EXACTLY BUT HE ASKED "IF ME AND MY WIFE WERE IN AN OPEN RELATIONSHIP, WOULD IT BE OK IF I WAS IN A RELATIONSHIP WITH YOU?" ██████████ WAS SHOCKED BY THE MESSAGE AND SHOWED IT TO HER HUSBAND. HER HUSBAND MESSAGED STAATS BACK SCOLDING HIM FOR THE INAPPROPRIATE CONTACT. STAATS REPLIED BACK THAT HE WAS JUST DOING SOME RESEARCH. AFTER THIS EXCHANGE ██████████ BLOCKED STAATS ON FACE BOOK.
